

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Carmen, Cagayan de Oro City, Misamis Oriental

23 March 2024, 6AM

## I. Situation Overview

On 06 February 2024 at around 1:09 AM, a fire incident occurred at Zone 5, Banava St., Brgy. Carmen, Cagayan de Oro City, Misamis Oriental.

Relative to the incident, the DSWD through its Field Office in Region X, together with the Local Government Unit (LGU) of Cagayan de Oro City, promptly provided relief assistance to support the immediate needs of the affected family.

A total of **₱11,239.50** worth of assistance was provided to the affected family composed of **₱7,916.50** from **DSWD** and **₱3,323.00** from the **Local Government Unit (LGU)** (see Annex D).
