

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Daldalaquiten Norte, Sinit, Ilocos Sur

18 March 2024, 6AM

## I. Situation Overview

On 21 February 2024 at around 8:00 AM, a fire incident occurred at Brgy. Daldalaquiten Norte, Sinit, Ilocos Sur.

Relative to the incident, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of Sinit, Ilocos Sur, provided relief augmentation to support the immediate needs of the affected families and individuals.

## II. Status of Affected Areas and Population

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. Daldalaquiten Norte, Sinit, Ilocos Sur** (see Annex A).

## III. Status of Displaced Population

### Outside Evacuation Center

**One (1) family** or **seven (7) persons** still temporarily staying with relatives (see Annex B).

## IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1) is totally damaged** and **one (1) is partially damaged** in **Brgy. Daldalaquiten Norte, Sinit, Ilocos Sur** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱57,601.00** worth of assistance was provided to the affected families composed of **₱37,601.00** from **DSWD** and **₱20,000.00** from the **Local Government Unit (LGU)** (see Annex D).
