



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Dolores, San Sebastian, Samar

02 June 2024, 6PM

I. Situation Overview

On 21 February 2024, a fire incident transpired in Brgy. Dolores, San Sebastian, Samar. The incident has led to displacement of two (2) families comprising five (5) individuals who are currently staying with their relatives.

Relative to the incident, the DSWD through its Field Office in Region VIII, together with the Local Government Unit (LGU) of San Sebastian, Western Samar, provided relief augmentation to support the immediate needs of the affected families and individuals. *Source: DSWD Field Office (FO) VIII*

II. Status of Affected Areas and Population

A total of **two (2) families** or **five (5) persons** were affected in **Brgy. Dolores, San Sebastian, Samar** (see Annex A).

III. Status of Displaced Population

a. Outside Evacuation Center

A total of **two (2) families** or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Dolores, San Sebastian, Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱54,583.00 worth of assistance was provided to the affected families; of which, ₱37,733.00 from DSWD and ₱16,973.00 from the Local Government Unit (LGU) (see Annex D).
