

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. East Kibawe, Kibawe, Bukidnon

28 March 2024, 6AM

I. Situation Overview

On 28 February 2024 at around 11:18 AM, a fire incident occurred in Purok 1A, Brgy. East Kibawe, Kibawe, Bukidnon. The fire was allegedly caused by an unplugged rice cooker that was left unattended. The fire was declared out at around 1:30 PM.

In response to the immediate needs of the affected families, the DSWD through its Field Office in Region X, together with the Local Government Unit (LGU) of Kibawe, has provided intervention through the provision of relief and financial assistance. To date, the affected families have already relocated and others are reconstructing their damaged houses.

II. Status of Affected Areas and Population

A total of **31 families** or **47 persons** were affected in **Brgy. East Kibawe, Kibawe, Bukidnon** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **31 families** or **47 persons** sought temporary shelter in **Brgy. East Kibawe Covered Court** in **Kibawe, Bukidnon** (see Annex B).

IV. Damaged Houses

A total of **three (3) houses** were **totally damaged** in **Brgy. East Kibawe, Kibawe, Bukidnon** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱121,212.74** worth of assistance was provided to the affected families composed of **₱44,212.74** from **DSWD** and **₱77,000.00** from the **Local Government Unit (LGU)** (see Annex D).
