

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Kahupian, Sogod, Southern Leyte

14 April 2024, 6AM

I. Situation Overview

On 04 March 2024 at around 6:00 PM, a fire incident occurred in Brgy. Kahupian, Sogod, Southern Leyte. The fire was declared out on the same day of the incident.

To support the immediate needs of the affected family, the DSWD through its Field Office in Region VIII, together with the Local Government Unit (LGU) of Sogod, has provided intervention through the provision of Food and Non-Food Items (NFIs) and Financial Assistance.

One (1) family or **six (6) persons** were affected in **Brgy. Kahupian** in **Sogod, Southern Leyte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Kahupian, Sogod, Southern Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱29,118.40** worth of assistance was provided to the affected family composed of **₱19,118.40** from the **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
