



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Lagasit, San Quintin, Pangasinan

16 April 2024, 6AM

I. Situation Overview

On 20 February 2024 at around 1:19 PM, a fire incident occurred in Brgy. Lagasit, San Quintin, Pangasinan. To date, upon coordination with the LGU, the affected families opted to stay with their relatives while waiting for the complete reconstruction of their houses.

Relative to the incident, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of San Quintin, Pangasinan, provided relief and financial assistance to support the immediate needs of the affected families and individuals

II. Status of Affected Areas and Population

A total of **six (6) families** or **19 persons** were affected in **Brgy. Lagasit, San Quintin, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **19 persons** is temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of six (6) houses were totally damaged in Brgy. Lagasit, San Quintin, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱228,202.00 worth of assistance was provided to the affected families composed of ₱128,202.00 from the DSWD, ₱75,000.00 from the Local Government Unit (LGU) and ₱25,000.00 from other stakeholders (see Annex D).
