

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Looc, Mandaue City, Cebu

30 January 2025, 6AM

I. Situation Overview

On 12 March 2024 at around 12:06 PM, a fire incident occurred at Brgy. Looc, Mandaue City, Cebu. The fire was declared out at around 2:16 PM.

II. Status of Affected Areas and Population

A total of **515 families** or **1,677 persons** were affected in **Brgy. Looc, Mandaue City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **515 families** or **1,677 persons** sought temporary shelter in **two (2) evacuation centers** in **Mandaue City, Cebu** (see Annex B).

IV. Damaged Houses

A total of **370 houses** were damaged; of which, **357 are totally damaged** and **13 are partially damaged** in **Brgy. Looc, Mandaue City, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱28,705,388.80** worth of assistance was provided to the affected families; of which, **₱10,105,388.80** from **DSWD** and **₱18,600,000.00** from the **Local Government Unit (LGU)** (see Annex D).
