

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Novallas, Tanjay City, Negros Oriental

30 January 2025, 6AM

I. Situation Overview

On 12 March 2024 at around 2:30 PM, a fire incident occurred at Sitio Sta. Rita, Brgy. Novallas, Tanjay City, Negros Oriental. The fire was declared out at around 3:20 PM.

One (1) family or eight (8) persons were affected in **Brgy. Novallas, Tanjay City, Negros Oriental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or eight (8) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Novallas, Tanjay City, Negros Oriental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱5,832.50** worth of assistance was provided to the affected families; of which, **₱5,222.50** from **DSWD** and **₱610.00** from the **Local Government Unit (LGU)** (see Annex D).
