





# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Pinili, Abulug, Cagayan

14 March 2024, 6PM

### I. Situation Overview

On 27 February 2024 at around 11PM, a fire incident occurred in Brgy. Pinili, Abulug, Cagayan. The cause of fire was determined to be an overheated air-conditioning unit. It was declared fire out at around 12AM the next day.

In response, the DSWD through its Field Office in Region II, together with the Local Government Unit (LGU) of Abulug, provided relief assistance to support the immediate needs of the affected family.

## II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Pinili, Abulug, Cagayan (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

One (1) family or six (6) persons are still temporarily staying with their relatives (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Pinili, Abulug, Cagayan (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **P34,080.00** worth of assistance was provided to the affected family; of which, **P14,080.00** from **DSWD** and **P20,000.00** from the **LGU** (see Annex D).
