



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tangcarang, City of Alaminos, Pangasinan

03 May 2024, 6PM

I. Situation Overview

On 21 February 2024 at around 2:00 PM, a fire incident occurred at Brgy. Tangcarang, City of Alaminos, Pangasinan.

II. Status of Affected Areas and Population

A total of **three (3) families** or **11 persons** are affected in **Brgy. Tangcarang, City of Alaminos, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **six (6) persons** are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of three (3) houses were damaged; of which, two (2) are totally damaged and one (1) is partially damaged in Brgy. Tangcarang, City of Alaminos, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱45,551.50 worth of assistance was provided to the affected families; of which, ₱30,052.50 from DSWD and ₱15,499.00 from the Local Government Unit (LGU) (see Annex D).
