## I. Situation Overview

On 22 March 2024 at around 1:11 PM, a fire incident occurred at Sitio Canggapak in Brgy. Parilla, Palompon, Leyte.

A total of **six (6) families** or **18 persons** are affected in **Brgy. Parilla, Palompon, Leyte** (see Annex A).

## III. Damaged Houses

A total of five (5) houses were damaged; of which, four (4) are totally damaged and one (1) is partially damaged in Brgy. Parilla, Palompon, Leyte (see Annex B).

## IV. Cost of Humanitarian Assistance Provided

A total of **₱48,999.24** worth of assistance was provided by the **DSWD** to the affected families (see Annex C).
