
DSWD DROMIC Report #1 on the Fire Incident in Brgy. Sindon Bayabo, Ilagan City, Isabela

as of 23 April 2024, 6PM

I. Situation Overview

On 12 April 2024, at approximately 01:22 PM, a fire incident transpired in Brgy. Sindon Bayabo, Ilagan City, Isabela, resulting in the destruction of two (2) residential houses. As of now, the fire-victim families are currently staying with their relatives.

Relative to the incident, the DSWD through its Field Office in Region II, together with the Local Government Unit (LGU) of Iligan City, provided relief augmentation to support the immediate needs of the affected families and individuals.

A total of **two (2) families** or **eight (8) persons** are affected in **Brgy. Sindon Bayabo, Ilagan City, Isabela** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **eight (8) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Sindon Bayabo, Ilagan City, Isabela** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱79,044.56** worth of assistance was provided to the affected families compose of **₱32,044.56** from **DSWD** and **₱47,000.00** from the **Local Government Unit (LGU)** (see Annex D).
