### I. Situation Overview

On 15 April 2024 at around 1:50 PM, a fire incident occurred in a landfill site at Sitio Napo, Brgy. Tapul, City of Talisay, Cebu which affected the livelihood of the families in the area.

# II. Status of Affected Areas and Population

A total of **250 families** or **862 persons** are affected in **Brgy. Tapul, City of Talisay, Cebu** (see Annex A).

# III. Cost of Humanitarian Assistance Provided

A total of ₱899,822.28 worth of assistance was provided to the affected families; of which, ₱574,600.00 from DSWD, and ₱104,550.00 from the Local Government Unit (LGU) (see Annex B).
