## **DSWD DROMIC Report on the Fire Incident in Brgy. 2 (Poblacion), City of Victorias, Negros Occidental**

12 April 2024, 6AM

### **I. Situation Overview**

On 06 April 2024 at around 3:00 PM, a fire incident occurred at Brgy. 2 (Poblacion), City of Victorias, Negros Occidental. The fire was declared out at around 5:25 PM.

A total of **five (5) families** or **eight (8) persons** were affected in **Brgy. 2 (Poblacion), City of Victorias, Negros Occidental** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

A total of **five (5) families** or **eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. 2 (Poblacion), City of Victorias, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱45,430.00** worth of assistance was provided to the affected families; of which, **₱35,430.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
