





DSWD DROMIC Report on the Fire Incident in Brgy. 5-Poblacion, Isabela, Negros Occidental

30 April 2024, 6AM

I. Situation Overview

On 11 April 2024 at around 03:30 PM, a fire incident occurred at Brgy. 5-Poblacion, Isabela, Negros Occidental. The fire was declared out at around 04:45 PM.

Relative to the incident, the DSWD through its Field Office in Region VI together with the Local Government Unit (LGU) of Isabela, Negros Occidental, provided relief augmentation to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. 5-Poblacion**, **Isabela, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** were **totally damaged** and **one (1)** were **partially damaged** in **Brgy. 5-Poblacion, Isabela, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\frac{1}{2}\$15,286.00 worth of assistance was provided to the affected families composed of \$\frac{1}{2}\$9,286.00 from DSWD and \$\frac{1}{2}\$6,000.00 from the Local Government Unit (LGU) (see Annex D).
