





DSWD DROMIC Report on the Fire Incident in Brgy. 8, Isabela, Negros Occidental

09 April 2024, 6AM

I. Situation Overview

On 18 March 2024 at around 1:30 PM, a fire incident occurred at Brgy. 8 (Poblacion), Isabela, Negros Occidental. The fire was declared out at around 3:15 PM.

II. Status of Affected Areas and Population

A total of six (6) families or 22 persons were affected in Brgy. 8, Isabela, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **22 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. 8, Isabela, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱35,188.00 worth of assistance was provided to the affected families; of which, ₱29,188.00 from DSWD and ₱6,000.00 from the Local Government Unit (LGU) (see Annex D).
