## DSWD DROMIC Report on the Fire Incident in Brgy. Afga, Tangalan, Aklan 19 April 2024, 6PM

### I. Situation Overview

On 16 April 2024 at around 10:00 PM, a fire incident occurred in Sitio Poeapo, Brgy. Afga, Tangalan, Aklan. The fire was declared out at around 10:55 PM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Tangalan, Aklan, provided relief augmentation to support the immediate needs of the affected family.

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Afga, Tangalan, Aklan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱6,918.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
