## DSWD DROMIC Report on the Fire Incident in Brgy. Agpipili, Lemery, Iloilo 01 April 2024, 6PM

### I. Situation Overview

On 24 March 2024 at around 2:00 PM, a fire incident occurred in Brgy. Agpipili, Lemery, Iloilo. The fire was declared out at around 2:30 PM.

**One (1) house** was totally damaged in **Brgy. Agpipili, Lemery, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,865.78** worth of assistance was provided to the affected family; of which, **₱5,865.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
