I. Situation Overview

On 30 March 2024 at around 6:00 PM, a fire incident occurred in Brgy. Alipata, Carles, Iloilo. The fire was declared out at around 6:55 PM.

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were totally damaged in **Brgy. Alipata, Carles, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,052.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
