## **DSWD DROMIC Report on the Fire Incident in Brgy. Bagacay, City of Passi, Iloilo**

18 April 2024, 6PM

### **I. Situation Overview**

On 24 March 2024 at around 8:48 AM, a fire incident occurred at Brgy. Bagacay, City of Passi, Iloilo. The fire was declared out at around 9:00 AM.
