

DSWD DROMIC Report on the Fire Incident in Brgy. Balaoi, Pagudpud, Ilocos Norte

16 April 2024, 6AM

I. Situation Overview

On 06 February 2024 at around 5:39 PM, a fire incident occurred in Brgy. Balaoi, Pagudpud, Ilocos Norte.

In response to the incident, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of Pagudpud, Ilocos Norte, provided intervention to support the immediate needs of the affected families by means of financial assistance.

II. Status of Affected Areas and Population

A total of **six (6) families** or **15 persons** were affected in **Brgy. Balaoi** in **Pagudpud, Ilocos Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **15 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were **totally damaged** in **Brgy. Balaoi, Pagudpud, Ilocos Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱55,000.00** worth of assistance was provided to the affected families composed of **₱30,000.00** from the **DSWD** and **₱25,000.00** from the **Local Government Unit (LGU)** (see Annex D).
