I. Situation Overview

On 18 February 2024 at around 2:00 PM, a fire incident occurred in Brgy. Balaoi, Pagudpud, Ilocos Sur.

II. Status of Affected Areas and Population

A total of **five (5) families** or **21 persons** were affected in **Brgy. Balaoi, Pagudpud, Ilocos Sur** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **five (5) families** or **21 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **three (3)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Balaoi, Pagudpud, Ilocos Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱72,500.00** worth of assistance was provided to the affected families; of which, **₱25,000.00** from **DSWD** and **₱47,500.00** from the **Local Government Unit (LGU)** (see Annex D).
