

DSWD DROMIC Report on the Fire Incident in Brgy. Baybay Lopez, Binmaley, Pangasinan

21 April 2024, 6AM

I. Situation Overview

On 21 March 2024 at around 2AM, a fire incident occurred in Brgy. Baybay Lopez, Binmaley, Pangasinan.

In response to the incident, the DSWD through its Field Office in Region I together with the LGU of Binmaley, provided relief augmentation to support the immediate needs of the affected families and individuals.

Moreover, the local government assumes the management of Internally Displaced Persons (IDPs) and commits to continuously provide interventions as necessary hence, the termination of this report.

II. Status of Affected Areas and Population

A total of **three (3) families** or **10 persons** were affected in **Brgy. Baybay Lopez, Binmaley, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **three (3) families** or **10 persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **three (3) houses** were **totally damaged** in **Brgy. Baybay Lopez, Binmaley, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱87,412.80** worth of assistance was provided to the affected families composed of **₱57,412.80** from **DSWD** and **₱30,000.00** from the **Local Government Unit (LGU)** (see Annex D).
