I. Situation Overview

On 31 March 2024 at around 12:30 PM, a fire incident occurred in Brgy. Bolosan Pequeno, Calinog, Iloilo. The fire was declared out at around 1:40 PM.

One (1) family or seven (7) persons temporarily stayed in a makeshift house in Brgy. Bolosan Pequeno, Calinog, Iloilo (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bolosan Pequeno, Calinog, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,506.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
