

DSWD DROMIC Report on the Fire Incident in Brgy. Buenavista, Himamaylan City, Negros Occidental

16 April 2024, 6AM

I. Situation Overview

At around 1:00 in the afternoon of March 23, 2024, a residential fire occurred in Barangay Buenavista, Himamaylan City. According to the City Social Welfare and Development Office (CSWDO), the incident left one (1) totally damaged house and displaced one (1) family or four (4) persons. The displaced family stayed with relatives in the same barangay. The fire was declared out at 2:15 in the afternoon.

To date, as per validation of the CSWDO, the displaced family now lives in their newly built house in the same barangay. DSWD Field Office VI provided food and non-food items to the affected family.

II. Status of Affected Areas and Population

One (1) family or two (2) persons were affected in **Brgy. Buenavista, Himamaylan City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Buenavista, Himamaylan City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,927.78** worth of assistance was provided to the affected family composed of **₱6,927.78** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
