I. Situation Overview

On 12 March 2024 at around 11:00 AM, a fire incident occurred at Brgy. Bulalacao, Sibalom, Antique. The fire was declared out at around 12:15 PM.

One (1) house was totally damaged in Brgy. Bulalacao, Sibalom, Antique (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P7,526.00** worth of assistance was provided to the affected families; of which, **P4,526.00** from **DSWD** and **P3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
