I. Situation Overview

On 31 March 2024 at around 1:30 PM, a fire incident occurred in Brgy. Cabanbanan, Oton, Iloilo. The fire was declared out at around 2:35 PM.

One (1) family or **one (1) person** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Cabanbanan, Oton, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,506.00** worth of assistance was provided to the affected families; of which, **₱8,506.00** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
