





# DSWD DROMIC Report on the Fire Incident in Brgy. Canturay, Sipalay City, Negros Occidental

13 April 2024, 6AM

#### I. Situation Overview

On 04 April 2024 at around 10:00 AM, a fire incident occurred at Brgy. Canturay, Sipalay City, Negros Occidental, due to a faulty electrical wiring. The fire was declared out at around 11:25 AM the same day.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Sipalay City, provided relief augmentation to support the immediate needs of the affected family.

One (1) house was totally damaged in Brgy. Canturay, Sipalay City, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱10,466.00** worth of assistance was provided to the affected family composed of **₱8,446.00** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
