I. Situation Overview

On 28 February 2024 at around 1AM, a fire incident occurred in Brgy. Caragasan, Alfonso Lista, Ifugao.

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or one (1) person temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Caragasan, Alfonso Lista, Ifugao (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P39.265.40** worth of assistance was provided to the affected families; of which, **P19,465.40** from **DSWD** and **P20,000.00** from the **Local Government Unit (LGU)** (see Annex D).
