

DSWD DROMIC Report on the Fire Incident in Brgy. Dangdangla, San Juan, La Union

16 April 2024, 6AM

I. Situation Overview

On 15 March 2024 at around 11:38 AM, a fire incident occurred at Brgy. Dangdangla, San Juan, La Union. The cause of fire is still under the investigation of San Juan Fire Station, La Union. The incident has led to displacement of two (2) families' equivalent to eight (8) individuals who opted to stay with their relatives.

Relative to the incident, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of San Juan, La Union, provided relief and financial assistance to support the immediate needs of the affected families and individuals. Moreover, the concerned LGU assumes the management of Internally Displaced Persons (IDPs) and to continuously provide interventions as necessary hence, the termination of this report.

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Dangdangla, San Juan, La Union** (see Annex A).

A total of **two (2) families** or **eight (8) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Dangdangla, San Juan, La Union** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱114,068.36** worth of assistance was provided to the affected family composed of **₱45,171.00** from **DSWD** and **₱68,897.36** from the **Local Government Unit (LGU)** (see Annex D).
