



DSWD DROMIC Report on the Fire Incident in Brgy. Dapdap, Tangalan, Aklan

30 April 2023, 6AM

I. Situation Overview

On 21 April 2024 at around 2:30 PM, a fire incident occurred in Brgy. Dapdap, Tangalan, Aklan. The fire was declared out at around 3:00 PM.

In response to the incident, the DSWD through its Field Office in Region VI, together with the MSWDO provided relief assistance to support the immediate needs of the affected family.

One (1) family or four (4) persons were affected in Brgy. Dapdap in Tangalan, Aklan (see Annex A).

Outside Evacuation Center One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Dapdap, Tangalan, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,918.00** worth of assistance from **DSWD** was provided to the affected family (see Annex D).
