





DSWD DROMIC Report on the Fire Incident in Brgy. Estefania, Bacolod City, Negros Occidental

16 April 2024, 6AM

I. Situation Overview

On 29 March 2024 at around 1:10 PM, a fire incident occurred at Brgy. Estefania, Bacolod City, Negros Occidental. The fire was declared out at around 2:15 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Bacolod City, provided relief assistance to support the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **two (2) families** or **10 persons** were affected in **Brgy. Estefania, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **10 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Estefania**, **Bacolod City**, **Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P25,432.00** worth of assistance was provided to the affected families composed of **P16,852.00** from **DSWD** and **P8,580.00** from the **Local Government Unit (LGU)** (see Annex D).
