

DSWD DROMIC Report on the Fire Incident in Brgy. Felisa, Bacolod City, Negros Occidental

16 April 2024, 6AM

I. Situation Overview

On 02 April 2024 at around 8:30 AM, a fire incident occurred at Brgy. Felisa, Bacolod City, Negros Occidental. The fire was declared out at around 9:15 AM. The incident has led to displacement of a family comprise of four (4) individuals who opted to stay with their relatives.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Bacolod City, Negros Occidental, provided relief assistance to support the immediate needs of the affected family.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Felisa, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,716.00** worth of assistance was provided to the affected family composed of **₱8,426.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
