

## DSWD DROMIC Report on the Fire Incident in Brgy. Gerongan, Lemery, Iloilo

16 April 2024, 6PM

### I. Situation Overview

On 04 April 2024 at around 8:26 PM, a fire incident occurred in Brgy. Gerongan, Lemery, Iloilo. The fire was declared out at around 8:50 PM.

**One (1) family or three (3) persons** were affected in **Brgy. Gerongan, Lemery, Iloilo** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Gerongan, Lemery, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,865.78** worth of assistance was provided to the affected families; of which, **₱5,865.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
