





# DSWD DROMIC Report on the Fire Incident in Brgy. Granada, Bacolod City, Negros Occidental

16 April 2024, 6AM

## I. Situation Overview

On 31 March 2024 at around 12:30 AM, a fire incident occurred at Brgy. Granada, Bacolod City, Negros Occidental. The fire was declared out at around 2:15 AM.

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

# IV. Damaged Houses

One (1) house was totally damaged in Brgy. Granada, Bacolod City, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱12,716.00 worth of assistance was provided to the affected family; of which, ₱8,426.00 from DSWD and ₱4,290.00 from the Local Government Unit (LGU) (see Annex D).
