

DSWD DROMIC Report on the Fire Incident in Brgy. Guinpanan, Moises Padilla, Negros Occidental

11 April 2024, 6PM

I. Situation Overview

On 27 March 2024 at around 8:30 AM, a fire incident occurred in Brgy. Guinpanan, Moises Padilla, Negros Occidental. The fire was declared out at around 9:45 AM.

II. Status of Affected Areas and Population

A total of **three (3) families** or **10 persons** were affected in **Brgy. Guinpanan, Moises Padilla, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **three (3) houses** were **totally damaged** in **Brgy. Guinpanan, Moises Padilla, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱23,783.34** worth of assistance was provided to the affected families; of which, **₱20,783.34** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
