





DSWD DROMIC Report on the Fire Incident in Brgy. Haguimit, La Carlota City, Negros Occidental

16 April 2024, 6PM

I. Situation Overview

On 08 April 2024 at around 3:00 PM, a fire incident occurred in Brgy. Haguimit, La Carlota City, Negros Occidental. The fire was declared out at around 4:45 PM.

II. Status of Affected Areas and Population

A total of **two (2) families** or **ten (10) persons** were affected in **Brgy. Haguimit**, **La Carlota City**, **Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **ten (10) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Haguimit, La Carlota City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}35,375.56\$ worth of assistance was provided to the affected families; of which, \$\mathbb{P}13,875.56\$ from **DSWD** and \$\mathbb{P}21,500.00\$ from the **Local Government Unit** (**LGU**) (see Annex D).
