

DSWD DROMIC Report on the Fire Incident in Brgy. Hilamonan, City of Kabankalan, Negros Occidental

02 April 2024, 6PM

I. Situation Overview

On 21 March 2024 at around 1:00 PM, a fire incident occurred in Brgy. Hilamonan, City of Kabankalan, Negros Occidental. The fire was declared out at around 1:40 PM.

One (1) family or three (3) persons were affected in **Brgy. Hilamonan, City of Kabankalan, Negros Occidental** (see Annex A).

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Hilamonan, City of Kabankalan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,927.78** worth of assistance was provided to the affected families; of which, **₱6,927.78** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
