I. Situation Overview

On 24 March 2024 at around 4:47 AM, a fire incident occurred at Brgy. Ibaba, Malabon City. The fire was declared out at around 6:20 AM.

A total of **six (6) houses** were **totally damaged** in **Brgy. Ibaba, Malabon City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱97,447.77** worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
