





# DSWD DROMIC Report on the Fire Incident in Brgy. Inoraguiao, Sta. Margarita, Western Samar

14 April 2024, 6AM

#### I. Situation Overview

On 29 February 2024 at around 9:05 AM, a fire incident occurred at Brgy. Brgy. Inoraguiao, Sta. Margarita, Western Samar. The fire was declared out at around 9:30 AM.

Relative to the incident, the DSWD through its Field Office in Region VIII, provided relief augmentation to support the immediate needs of the affected families and individuals.

One (1) house was partially damaged in Brgy. Inoraguiao, Sta. Margarita, Western Samar (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **P698.65.00** worth of assistance (family food pack) was provided by **DSWD** to the affected family (see Annex D).
