I. Situation Overview

On 14 March 2024 at around 1:00 PM, a fire incident occurred in Brgy. Jaena Sur, Jamindan, Capiz. The fire was declared out at around 1:35 PM.

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One house was totally damaged in **Brgy. Jaena Sur, Jamindan, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,693.50** worth of assistance was provided to the affected family; of which, **₱7,193.50** from **DSWD** and **₱5,500.00** from the **Local Government Unit (LGU)** (see Annex D).
