I. Situation Overview

On 14 March 2024 at around 1:00 PM, a fire incident occurred in Brgy. Jaena Sur, Jamindan, Capiz. The fire was declared out at around 1:35 PM.

One (1) family or two (2) persons were affected in Brgy. Jaena Sur in Jamindan, Capiz (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One house was totally damaged in Brgy. Jaena Sur, Jamindan, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱12,693.50 worth of assistance was provided to the affected family; of which, ₱7,193.50 from DSWD and ₱5,500.00 from the Local Government Unit (LGU) (see Annex D).
