18 April 2024, 6AM

I. Situation Overview

On 26 March 2024 at around 11:20 AM, a fire incident occurred in Brgy. Lindero, Laua-An, Antique. The fire was declared out at around 12:35 PM.

Outside Evacuation Center

One (1) family or eight (8) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Lindero, Laua-An, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,136.00** worth of assistance was provided to the affected families; of which, **₱8,136.00** from **DSWD** and **₱1,000.00** from the **Local Government Unit (LGU)** (see Annex D).
