## **DSWD DROMIC Report on the Fire Incident in Brgy. Longos, Malabon City**

18 April 2024, 6PM

### **I. Situation Overview**

On 03 April 2024 at around 2:27 AM, a fire incident occurred at Gen. P. Borromeo St., Brgy. Longos, Malabon City. The fire was declared out at around 2:51 AM.
