
DSWD DROMIC Report on the Fire Incident in Brgy. Lumbo, Pototan, Iloilo

19 April 2024, 6PM

I. Situation Overview

On 06 April 2024 at around 10:43 AM, a fire incident occurred in Brgy. Lumbo, Pototan, Iloilo. The fire was declared out at around 11:17 AM.

In response to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Pototan, Iloilo, provided relief assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **four (4) persons** were affected in **Brgy. Lumbo, Pototan, Iloilo** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

One (1) family or **four (4) persons** sought temporary shelter at the **Barangay Hall** in **Brgy. Lumbo, Pototan, Iloilo** (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Lumbo, Pototan, Iloilo** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,056.00** worth of assistance was provided to the affected families composed of **₱8,056.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex E).
