





DSWD DROMIC Report on the Fire Incident in Brgy. Mancilang, Madrilejos, Cebu

13 April 2024, 6AM

I. Situation Overview

On 28 February 2024 at around 7:55 AM, a fire incident occurred at Brgy. Mancilang, Madrilejos, Cebu. The fire was declared out at around 8:50 AM.

II. Status of Affected Areas and Population

A total of **nine (9) families** or **30 persons** were affected in **Brgy. Mancilang, Madrilejos, Cebu** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **nine (9) families** or **30 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of nine (9) houses were damaged; of which, eight (8) are totally damaged and one (1) were partially damaged in Brgy. Mancilang, Madrilejos, Cebu (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\frac{P}{246,930.75}\$ worth of assistance was provided to the affected families composed of \$\frac{P}{133,745.00}\$ from the **DSWD** and \$\frac{P}{113,185.75}\$ from the **Local Government Unit (LGU)** (see Annex D).
