I. Situation Overview

On 23 March 2024 at around 11:00 AM, a fire incident occurred at Sitio Mat-i, Brgy. Mayang, Tubungan, Iloilo. The fire was declared out at around 12:30 PM.

One (1) house was totally damaged in **Brgy. Mayang, Tubungan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱14,532.00 worth of assistance was provided to the affected family; of which, ₱3,978.00 from DSWD and ₱10,554.00 from the Local Government Unit (LGU) (see Annex D).
