





DSWD DROMIC Report on the Fire Incident in Brgy. Morobuan, Jordan, Guimaras

05 April 2024, 6AM

I. Situation Overview

On 22 March 2024 at around 7:30 AM, a fire incident occurred in Brgy. Morobuan, Jordan, Guimaras, and was declared fire out at around 9:40 AM. The incident has led to displacement of three (3) families equivalent to 13 individuals.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Jordan, Guimaras, provided relief and financial assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **three (3) families** or **13 persons** were affected in **Brgy. Morobuan, Jordan, Guimaras** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **13 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. Morobuan, Jordan, Guimaras (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}34,518.00\$ worth of assistance was provided to the affected families composed of \$\mathbb{P}25,518.00\$ from DSWD and \$\mathbb{P}9,000.00\$ from the Local Government Unit (LGU) (see Annex D).
