## DSWD DROMIC Report on the Fire Incident in Brgy. Pajo, Lambunao, Iloilo

18 April 2024, 6AM

### I. Situation Overview

On 25 March 2024 at around 9:55 PM, a fire incident occurred at Purok 1, Brgy. Pajo, Lambunao, Iloilo. The fire was declared out at around 10:40 PM.

**One (1) family or two (2) persons** were affected in **Brgy. Pajo, Lambunao, Iloilo** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or two (2) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Pajo, Lambunao, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱13,144.00** worth of assistance was provided to the affected families; of which, **₱7,184.00** from **DSWD** and **₱5,960.00** from the **Local Government Unit (LGU)** (see Annex D).
