I. Situation Overview

On 10 March 2024 at around 7:30 AM, a fire incident occurred in Brgy. Palma, Barbaza, Antique. The fire was declared out at around 8:25 AM.

A total of **two (2) families** or **seven (7) persons** were affected in **Brgy. Palma, Barbaza, Antique** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Palma, Barbaza, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱21,252.00** worth of assistance was provided to the affected families; of which, **₱16,252.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
